### **All USA Hockey rules apply with the following additions:**

1. No outgoing seniors or 7th graders allowed.
2. 2 fighting penalties may result in the players immediate removal from the league for the remainder of the session.
3. Players rostered on Varsity and JV teams serving suspensions cannot play on either team until the suspension is served with the original team.
4. Tie games in playoffs will be decided with 1 sudden death overtime, then a shootout. Championship games will be sudden death overtime.
5. Zero tolerance will be strictly enforced.
6. All penalties and procedures follow USA Hockey guideline.
7. Divisions will be decided on final amount of teams.

There will be no refunds to teams unless the rink is unable to provide a facility in adequate playing condition for a majority of scheduled games. Games may be rescheduled as need arises. The first three games of the season will be on a temporary game by game schedule so that teams may be moved between divisions to achieve parity. Your team may be moved. Failure of any team to pay league fees in full as per above payment schedule, at the discretion of rink management, will be dropped from the league with no refund of moneys previously
