The undersigned agrees to fully indemnify and hold **The Darien Sportsplex** and its agents harmless from any and all claims, which may be asserted by the undersigned or on the behalf of the minor child. The undersigned further agrees to reimburse **The Darien Sportsplex** for any and all costs of litigation and attorney's fees in the event a claim is asserted against **The Darien Sportsplex** or one of its agents.*

Contracts paid in full by the **6/1/10** deadline, will receive a 5% discount off the total amount. Contracts will only be accepted with a minimum of **10 ice slots**.

ADDITIONAL FEES:

\$10 – contract changes in excess of 12 ice slots

\$25 – final balance not paid by due date **7/19/10**

*New contracts are required to be turned in by **midnight** on the deadline date or a fee of \$10.00 will be charged. There will also be a \$25 fee for payment received after the balance due date of 7/19/10 along with suspension of privileges. **All contracts need to be paid in full by the completion of the session.***

ICE-SKATING PROGRAM WAIVER & RELEASE

IMPORTANT INFORMATION

The Darien Park District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The Darien Park District continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this program must recognize that there is an inherent risk of injury when choosing to participate in recreational activities

You are solely responsible for determining if you or your minor child/ward are physically fit and/or adequately skilled for the ice-skating activities. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

WARNING OF RISK

Ice-skating is intended to challenge and engage the physical, mental and emotional resources of the participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including but not limited to head injury, neck or back injury, wrist and ankle fractures, and other orthopedic injuries to limbs and joints. All hazards and dangers cannot be foreseen. The very nature of ice-skating is risky, including but not limited to slip and falls, colliding with other players of varying degrees of skill (including being struck from behind), tripping on irregular ice surfaces, cuts from skate blades, inadequate or defective equipment, ill-fitting skates, failure in supervision or instruction, horseplay, carelessness, poor technique, poor conditioning, rule violations, striking a stationary object, premises defects outside the rink, and all other risks inherent to the sport of ice-skating. In this regard, it must be recognized that it is impossible of the Darien Park District to guarantee absolute safety.

WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK

Please read this form carefully and be aware that in signing up and participating in this program/activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program/activity (including transportation services and vehicle operations, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity against the Darien Park District, including its officials, agents, volunteers and employees.

I have read and fully understand the above important information, warning or risk, assumption of risk and waiver and release of all claims. If registering on-line or via fax, my on-line or facsimile signature shall substitute for and have the same legal effect as an original form signature.

CONTRACT CONFIRMATIONS - Contracts will be awarded on a first come, first serve basis. **Contracts will only be accepted with a purchase of ten or more contracted sessions.** You will receive a confirmation by mail or in person within two weeks after the due date. **No contract is processed prior to the due date.**

CONTRACT CHANGES REQUESTED AFTER THE DUE DATE WILL BE PROCESSED AS FOLLOWS:

1. Changing from one day to another will be approved if space allows on the new day and time. (All changes must be in writing).
2. **Any contract changes requested after week 2 will have a \$10 fee in addition to any ice fees.**

CONTRACT FEES – All fees are designated for each contract time. Half hour slots will be available for each time with the exception of the 4:10 pm and 5:05 pm times Mon.-Fri., and the 7:25 time on Sat. The fee for these half hour slots will be \$5.

FREESTYLE RULES

CONTRACT ICE: Walk-ons will be determined by first-come first-serve basis. There are **no** lifts allowed on any freestyle with 10 or more skaters (unless stated otherwise).

WALK-ON AND CREDITS: If you wish to walk-on for additional sessions, you will be charged the same price you pay for contract ice. **You must pay before skating these sessions.** If you miss a session, you will be issued a **make-up**, to be used at a future date and time, as long as it is within the current contract. **ABSOLUTELY** no carryovers. We will allow a skater to make-up on a session that costs less than the one they missed, if they ask to do so. In this instance, there will be no monetary difference; it will be considered an even exchange.

UNDER NO CIRCUMSTANCES WILL MAKE-UPS BE CARRIED TO A FUTURE CONTRACT

The director, at her discretion, gives credits. In the instance of a credit, a doctor's note must accompany your request.

CHECKING-IN: All contract holders are responsible for check-in with the **ICE MONITOR** or at the **FRONT DESK**. Failing to do so, your child may be called off the ice (even if involved in a lesson) to check in!!!

MUSIC PLAYING POLICY: *The person skating to his/her program has the absolute right-of-way!!* The rotation of music during a session consists of two pro requests and one regular request. If the ice monitor calls your name and you do not wish to go, your tape/CD will than be placed at the end of the line. Re-starting tapes/CDs is discouraged and may be denied. If you know you will have a Pro's request, please say "NO" when your name is called.

PRO REQUESTS: The pro **MUST** be currently giving the student a lesson at the time of request. Music will be played **ONE** time per session, either a pro request or regular rotation.

Level Requirements

OPEN FREESTYLE:	Open to all levels of skaters
LOW FREESTYLE:	Must have passed F/S 1 to be on this freestyle
PRE-JUV/JUV:	Must have passed Pre-Juvenile F/S test (or F/S 5 in ISI)
JUV/ HI:	Must have passed Juvenile F/S test (or F/S 6 in ISI)
ADULT:	Must be over 25 years old
ICE DANCE:	For ice dancing only; no Freestyle skating allowed

IN REGARDS TO SKATERS QUALIFYING FOR FREESTYLE LEVELS: If there is a question about a skater's ability to qualify for a specific freestyle, the skater in question will be tested by a "pro" chosen by the skating director and not by the private instructor. If the skater then meets the qualifications of the freestyle in question, they will be allowed to skate. **The Darien Sportsplex reserves the right to cancel or change level requirements on certain sessions, due to unforeseen circumstances.**

TEMPER/FRUSTRATION: Any skater unable to control his/her temper will be asked to leave the ice. *Ex: Stomping, Swearing, Screaming, and Dragging of your toe pick Etc..* No credit will be given for the session under this circumstance. Any disrespect resulting in a confrontation with management regarding this issue of proper behavior, will result in immediate suspension for a week from the ice. (No make-ups or credits allowed.)

PARENTAL RULES: *No parent/parents* are allowed in any of the penalty/players boxes, **with the exception of the Ice Monitor.** There will be no yelling to your son/daughter from the stands (It is very distracting to others and endangers your child). If you as a parent can not follow these simple rules, the following will apply to you also:

VIOLATIONS: Any skater who violates these or any amendment to these rules will be subject to the following penalties:

FIRST OFFENSE:	Verbal warning (which could include leaving the ice.)
SECOND OFFENSE:	Written warning to parents(s)
THIRD OFFENSE:	Suspension of skating privileges
FOURTH OFFENSE:	Expulsion from all Darien Sportsplex Programs

GUEST PROS AND CHOREOGRAPHERS: Arrangements for a guest pro (choreographer, ballet) must be prearranged through the skate school office and approved by the skating director. All guest pros **MUST** have a current resume on file, along with a certificate of insurance, and a "letter of intent". We will not allow a guest pro on our ice without the above materials.
